

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to the [www.HansonOrtho.com](http://www.HansonOrtho.com) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to HansonOrtho include Grossmont Orthopaedic Medical Group and the San Diego Stem Cell Treatment Center, Inc. The HansonOrtho website is a news and information site. By using the HansonOrtho website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

HansonOrtho may collect personally identifiable information, such as your name. HansonOrtho may also collect anonymous demographic information, which is not unique to you, such as your gender and Message and/or brief description of your problem, injury or disease. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by HansonOrtho. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the HansonOrtho website.

### **Use of your Personal Information**

HansonOrtho collects and uses your personal information to operate its website(s) and deliver the services you have requested.

HansonOrtho may also use your personally identifiable information to inform you of other products or services available from HansonOrtho and its affiliates. HansonOrtho may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

HansonOrtho does not sell, rent or lease its customer lists to third parties.

HansonOrtho may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to HansonOrtho, and they are required to maintain the confidentiality of your information.

HansonOrtho may keep track of the websites and pages our users visit within HansonOrtho, in order to determine what HansonOrtho services are the most popular.

This data is used to deliver customized content and advertising within HansonOrtho to customers whose behavior indicates that they are interested in a particular subject area.

HansonOrtho will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on HansonOrtho or the site; (b) protect and defend the rights or property of HansonOrtho; and, (c) act under exigent circumstances to protect the personal safety of users of HansonOrtho, or the public.

### **Use of Cookies**

The HansonOrtho website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize HansonOrtho pages, or register with HansonOrtho site or services, a cookie helps HansonOrtho to recall your specific information on subsequent visits.
